Calling All Vendors

The Concordia Fall Fest Committee is looking for commercial food exhibitors. To apply for your booth at our 2024 event, please complete the form on the back. If you provide an email address, a confirmation notice will be sent upon receiving registration. **Please turn in registrations by August 31st.** Registrations received after August 31st will have to be approved by the Fall Fest Committee and will be charged an additional \$5.

Booth Information

Booth spaces for commercial vendors are \$75. You will need to bring your own table and chairs, these items will not be provided. Before you set up your booth, please check in at the Fall Fest Information Barn, located at the intersection of 6th and Washington. All booth spaces will be marked and numbered with chalk on the sidewalk and street. Booths will not be in front of entrances to businesses. You may unload between 7 a.m. to 8 a.m. on Saturday, September 28th . All cars should be parked in designated parking by 8:00 a.m. Each vendor receives a parking pass. Which should be placed on drivers side dash. Booths should be completely set up by 9:00 a.m. The day e vents will run approximately from 9 a.m. to 3 p.m.

We ask that you stay setup until 3 p.m. Commercial vendors have the choice to stay for the evening festivities from 8 p.m. to 12 a.m. Please indicate this on your form. Vendor space will be filled based on first right of refusal and then first come, first served basis. Two vendors of each product or service will be allowed.

Vendor Packets

Vendor Packets will **NOT** be mailed. They will need to be picked up at the Information booth by Century 21, that morning before you start setting up. Packets will include sales tax forms, maps, and parking permits . Please place the parking permit in the front window of your vehicle. All vehicles must be off the street by 9:00 a.m. There is reserved parking for booth exhibitors behind The Citizens National Bank. Vendor maps will be emailed the week of Fall Fest

All vendors will receive a preprinted sales tax certificate, Kansas Retailers' Event Sales Tax Special Instructions form, and an envelope to mail remittance and tax return to the Department of Revenue which will be included in the packet. Each vendor must display their sales certificate during the event.
